The ornamental design for a trailing end of a spinal implant, substantially as shown and described.

DESCRIPTION

FIG. 1 is a pespective view of the trailing end of a spinal implant in accordance with a third embodiment of my claimed design with the remainder of the implant shown in hidden line and forming no part of the claimed design;

FIG. 2 is an end view of FIG. 1;

FIG. 3 is a side elevational view of FIG. 2 with the remainder of the implant shown in hidden line and forming no part of the claimed design;

FIG. 4 is a perspective view of the trailing end of a spinal implant in accordance with a fourth embodiment of my claimed design with the remainder of the implant shown in hidden line and forming no part of the claimed design;

FIG. 5 is an end view of FIG. 4:

FIG. 6 is a side elevational view of FIG. 4 with the remainder of the implant shown in hidden line and forming no part of the claimed design;

FIG. 7 is a perspective view of the trailing end of a spinal implant in accordance with a fifth embodiment of my claimed design with the remainder of the implant shown in hidden line and forming no part of the claimed design;

FIG. 8 is an end view of FIG. 7;

FIG. 9 is a side elevational view of FIG. 7 with the remainder of the implant shown in hidden line and forming no part of the claimed design;

FIG. 10 is a pespective view of the trailing end of a spinal implant in accordance with a sixth embodiment of my claimed design with the remainder of the implant shown in hidden line and forming no part of the claimed design;

FIG. 11 is an end view of FIG. 10;

FIG. 12 is a side elevational view of FIG. 10 with the remainder of the implant shown in hidden line and forming no part of the claimed design;


FIG. 13 is a perspective view of the trailing end of a spinal implant in accordance with a seventh embodiment of my claimed design with the remainder of the implant shown in hidden line and forming no part of the claimed design;

FIG. 14 is an end view of FIG. 13; and,












